#### **Action Items:**

- 1. Authorize the Norwalk Police Department to replace its current issued service handgun, the Sig Sauer P- 229R .40 caliber semi-automatic pistol, with the Glock 17 Generation 4 9mm semi-automatic pistol. The Department's current pistol has been in service for over five years and due for replacement within the next 4 years. Making the transition at this time allows the Department to get maximum trade-in value for the older weapons. The purchase would entail 185 Glock 17 Generation 4 9mm semi-automatic handguns, 25 Glock 34 Generation 4 9mm semi-automatic handguns for the Emergency Services Unit Tactical Team, 10 Glock 17 Simunitions training pistols, and holster and magazine holder replacements for each officer.

**CALL TO ORDER**

The Chair called the meeting to order at 7:35 PM. A quorum was present.

**APPROVAL OF MINUTES**

**Minutes of the January 28th Meeting**

**Minutes of the February 25th Meeting**

- \*\* THE CHAIR MOVED TO ACCEPT THE MINUTES OF THE FEBRUARY 25GH MEETING WITH THE FOLLOWING CORRECTION:**
- A. THE FOLLOWING CLARIFICATION WAS MADE: MS. DIANE LAURICELLA DID NOT START THE UNDERGROUND STORAGE TANK PROGRAM, BUT WAS A STATE WORKER WHO HELPED GET THE PROJECT COMPLETED.**
- \*\* MOTION PASSED WITH TWO (2) ABSTENTIONS (BONENFANT & SERASIS)**

**PUBLIC PARTICIPATION**

Ms. Lauricella came forward and clarified for the record that she did not start the underground storage tank program, but rather helped them execute the program as a state worker.

In regards to the resolution on tonight's agenda, Ms. Lauricella stated that she has some background in OSHA, HAZMAT and emergency management, and that she was the first and only chair of the local emergency planning committee. She stated that the group was charged with putting together an emergency management plan and to facilitate the input of several different departments in the late 80s and early 90s. She stated that it is important to cooperate on a regional level, particularly in light of large scale issues such as natural hazards. Ms. Lauricella stated that she is very interested in this prospect, and would like to know how often Norwalk's citizen group meets for emergency department management. She further stated that she would be happy to discuss this matter offline with Ms. DeLuca.

**Council Member Melendez entered the meeting at 7:40 PM.**

Ms. Lauricella stated, as far as public participation, it has been unusually difficult to get a response to certain Council Members, specifically mentioning Council Members DePalma and Bonenfant. She stated that she appreciates how busy they must be, but that she is similarly busy and that there appears to be an unwillingness to respond to emails or phone calls. She stated that there are a number of things she would like to discuss with the Chair, among them more robust agendas. She stated that this committee is important, and that she would like to believe that the lack of communication isn't deliberate, but rather the consequence of busy schedules and committee members not being aware some of their constituents have good backgrounds and can help.

### **NEW BUSINESS**

#### **Resolution Adopting the 2016-2021 South Western Region Natural Hazard Mitigation Plan Update**

The Chair read the resolution into the record as follows:

*WHEREAS, the City of Norwalk Common Council recognizes the threats that the natural hazards pose to people and property within the City of Norwalk; and*

*WHEREAS, the City of Norwalk, in collaboration with the Western Connecticut Council of Governments (WESTCOG), has prepared a multi-hazard mitigation plan, hereby known as the*

*2016-2021 South Western Region Natural Hazard Mitigation Plan Update (the Mitigation Plan Update) in accordance with the Disaster Mitigation Act of 2000; and*

*WHEREAS, the 2016-2021 South Western Region Natural Hazard Mitigation Plan Update has identified mitigation goals and actions to reduce or eliminate long-term risk to people and property from the impacts of future hazards and disasters that affect the City of Norwalk and the region; and*

*WHEREAS, public and committee meetings were held between August 14, 2013 and October 8, 2015 in furtherance of the development and review of the Mitigation Plan Update; and*

*WHEREAS, the Federal Emergency Management Agency/Department Homeland Security has approved the 2016-2021 South Western Region Natural Hazard Mitigation Plan Update, on condition of local adoption, which enables the City of Norwalk to apply for Hazard Mitigation Grant funding; and*

*WHEREAS, adoption by the City of Norwalk Common Council of the Mitigation Plan Update demonstrates Norwalk's commitment to hazard mitigation and the achievement of the goals outlined in the City of Norwalk's section of the Mitigation Plan Update.*

*NOW THEREFORE, BE IT RESOLVED, that the City of Norwalk Common Council hereby adopts the 2016-2021 South Western Region Natural Hazard Mitigation Plan Update.*

**\*\* COUNCIL MEMBER DEPALMA MOVED TO ACCEPT RESOLUTION RE:  
ADOPTING THE 2016-2021 SOUTH WESTERN REGION NATURAL HAZARD  
MITIGATION PLAN UPDATE.**

Ms. DeLuca stated that they began the process of developing this plan 2 years ago, and that it allows the City to apply for FIMA. Without a premeditated disaster plans, the City is unable to receive funds, whereas this agreement gives them preliminary approval by FIMA. She stated, if this item is ratified, it is good for the next 5 years. She stated that they reap a huge benefit should there be another disaster, and that the timeline provided in the packet outlines the process they went through. Ms. DeLuca stated that they worked with the Nature Conservancy to arrange for public workshops, and held a public meeting on February 12th, in addition to online surveys, and media releases. She stated that working through Western CT COG is a time and money saver for the municipality, and in about 3 years, they will start the process to revise again. She stated that the full document is roughly 700 pages, and goes through numerous disaster procedures. Ms. DeLuca provided a 1 page summary to the committee which read as follows:

*The HMP was prepared in accordance with 44 CFR 2016.6 of the Disaster Mitigation Act of 2000 (DMA; Public Law 106-390). The Disaster Mitigation Act of 2000 (DMA) established a national program for pre-disaster mitigation and helps expedite the administration of disaster relief to impacted areas. A key requirement of the DMA is the need for a FEMA-approved HMP, which keeps the region and its municipalities eligible for Hazard Mitigation Assistance (HMA) funding. During the past 2 years, the WCCOG worked with municipal staff, as well as local and regional stakeholders to identify and incorporate critical information. This HMP builds on previous iterations in 2005 and more recently in 2011, public comment and WCCOG also held community information sessions throughout the region.*

*The South Western Region (SWR) is comprised of eight municipalities which form the southwestern panhandle of Connecticut. The region shares its western boundary with New York's Westchester County, is bounded by Long Island Sounds (LIS) to the south, and extends inland approximately 13 miles.*

*The Western Connecticut Council of Governments (WCCOG, formerly SWRPA) received Federal Emergency Management Agency (FEMA) funds through the Connecticut Division of Emergency Management and Homeland Security (DEMHS) to develop the 2016 Natural Hazard Mitigation Plan Update (HMP) for the following municipalities listed below:*

- A. Town of Darien*
- B. City of Stamford*
- C. Town of Greenwich*
- D. Town of Weston*
- E. Town of New Canaan*
- F. Town of Westport*
- G. City of Norwalk*
- H. Town of Wilton*

*A key goal of this plan is to identify the natural hazards likely to affect the SWR, its eight municipalities and the over 365,000 residents. The plan also identifies areas vulnerable to the aforementioned natural hazards, and incorporates appropriate strategies aimed towards mitigation. Consistent with FEMA and DEMHS goals, the HMP serves to reduce loss of life and property, economic disruptions and the cost of post-disaster recovery for the region's communities.*

*Specific goals and objectives of the document include:*

- A. Protecting public safety and preventing loss of life and injury;*
- B. Reducing harm to existing and future development;*

- C. Preventing damage to a community's unique economic, cultural, and environmental assets;*
- D. Minimizing operational downtime and accelerating the recovery of government and business after disasters;*
- E. Reducing the costs of disaster response and recovery, as well as the exposure to risk for first responders; and*
- F. Helping accomplish other community objectives, such as leveraging capital improvements, infrastructure protection, open space preservation, and economic resiliency.*

*Project benefits include:*

- A. Identifying cost effective actions for risk reductions;*
- B. Directing resources to the greatest risks and vulnerabilities*
- C. Building partnerships by involving people, organizations, and businesses;*
- D. Increasing education and awareness of hazards and associated risk;*
- E. Aligning risk reduction with other community objects; and*
- F. Providing eligibility to receive FEMA federal hazard mitigation grant funds*

*Upon adoption of the 8 participating communities (through the Resolution), the Hazard Mitigation Plan will be in effect from 2016-2021.*

Council Member Serasis inquired about the nature of the funding the City is eligible to apply for under this agreement. Ms. DeLuca stated that the funding varies depending on the project and the nature of the damage, and that these grants tend to be very competitive. She further stated that the bulk of them are mitigation focused, and that most of the big project are public works related items such as culverts, bridges and flood plain management.

Council Member DePalma asked how a private citizen would go about applying for funding through this arrangement- whether directly, on behalf of the citizen or all of the above. Ms. DeLuca stated that all of the above are options, depending on the nature of the funding and the intended usage of said funds.

Council Member DePalma asked how individuals will know they are in a danger zone. Council Member Bonenfant stated that most people in a flooding danger zone are notified by their insurance companies.

The Chair encouraged Ms. DeLuca to contact herself and Ms. Dixon with any ideas regarding the execution of or communication of the Disaster Mitigation plan.

Council Member Bonenfant asked if there was any funding the City has put in in regards to the development of the Disaster Mitigation fund. Ms. DeLuca stated that the City received funding for the development of the plan from an alternate source. Council Member Bonenfant asked if there was any responsibility on the part of Norwalk for the other towns and cities in the WESTCOG group. Ms. DeLuca stated that during a disaster, Norwalk is solely responsible for doing their own damage control, however in the event another town requests the use of a bulldozer (or something comparable), then the City will attempt to accommodate them.

Mr. Simms asked how reimbursement would work, should one of the towns borrow a resource from Norwalk. Ms. DeLuca stated that the reimbursement would move in the form of a request from Norwalk's Department of Public Works, to the other town's Department of Public Works. If anything is damaged during the course of mutual aid, the municipality responsible is liable to help replace or repair it. There is higher level reimbursement for FEMA level disasters, and the City receives a certain percentage back.

Council Member Bonenfant asked specifically what the City is signing on for for 5 years. Ms. DeLuca stated that they are committing to the use of the pre-mitigation plan. Council Member Bonenfant asked what would happen in the event that they found the plan ineffective, and decided the City would be better served with an alternate plan. Ms. DeLuca stated that once it is adopted, it is good for 5 years, and the only thing it allows the City to do is applying for funding. In the event there is a disaster and the City doesn't want to apply for funding, it is solely their discretion and there is no obligation on the part of the City. Ms. DeLuca clarified that eligibility to apply for funding isn't tied to the COG, but the disaster mitigation plan, which tends to be more lengthy, time consuming and expensive when undertaken as an individual municipality. She stated that their current plan expires in June, so there isn't enough time to do this at present, however if it is something they wish to revisit in 2019, that is entirely possible.

The Chair asked how many times the City has signed on for this arrangement, and Ms. DeLuca stated that this is the third renewal.

Council Member Bonenfant expressed his concern that Norwalk's constituents may suffer as a result of being combined with the neighboring municipalities, and in the event of an emergency, they don't want to be waiting in line for resources that are rightfully theirs to utilize. Ms. DeLuca acknowledged that this is a unique arrangement due to funding and staff resources, and that this arrangement allows the City the ability to apply for funds in the event of a crisis.

The Chair noted that this saves the City money, and Council Member Serasis stated that this arrangement acts as a safety net, should a disaster come to pass.

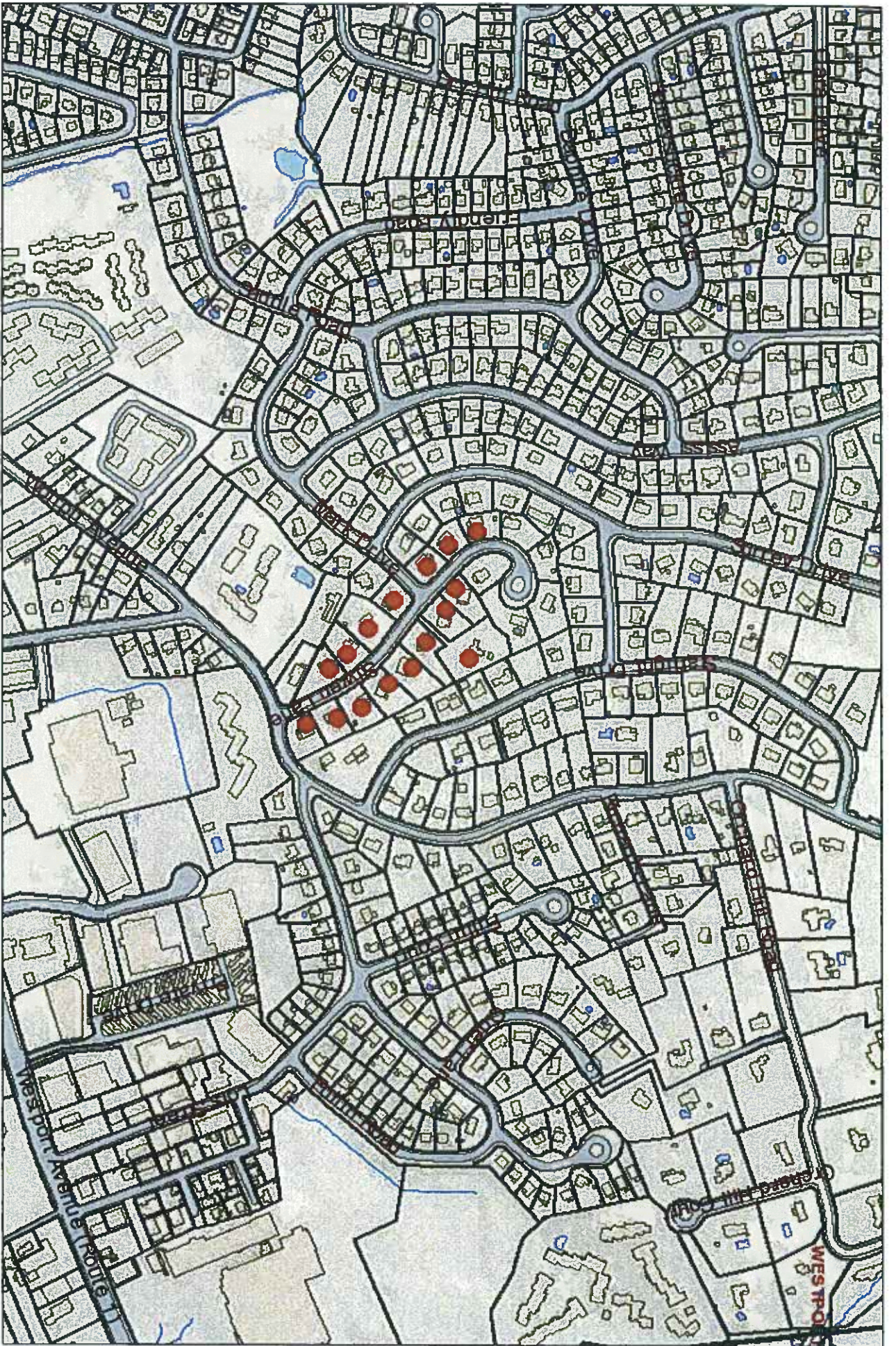

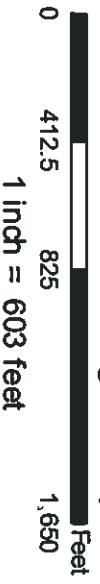

## Why We Need Street Lights on Silwen Lane

I understand from the original owners fifty one years ago when the homes were built they wanted Silwen Lane to look like a country road without lights.

All the homes in the "Surrey Estates" had lights except the opening to the estate from Wolfpit to Silwen. At that time Wolfpit Ave had a lot of woods - home & condos were not built then.

Times have changed - neighborhood has changed. The street is very dark at night that if you look out side your window you cannot see anything unless it's a full moon or neighbors have their lights on.

No one parks their car overnight on the street they park in their driveway or garage. Many times there has been parked cars on the street for a while with lights on & persons inside. Don't know if they are dealing drugs or not. It's so dark to take a walk on Silwen if you wanted to walk.

Teenagers are constantly cutting thru back yards at Redwood x Surrey Drive to get to Silwen and to Wolfpit Ave day or night. Hanging out in the middle of the Street and you do not know they are out there until you go outside and hear their voices.

The house on the top of the hill was shot at around two years ago during the evening. Police were called the owner said was spray painted on the large phone box at the beginning of Silwen a while back.

What happened to me personally was one evening I was downstairs watching T.V. in the back of the house. No lights were in the front of the house. Door bell rings & rings. I went upstairs and said who is it - no answer. I waited a minute and turned on the light and opened the door. I heard some one running down the street. Was this an attempt to break in? I did call the police.

## Chapter 77. Peddlers, Street Vendors and Solicitors

[HISTORY: Adopted City of Norwalk Common Council 3-14-1989.<sup>[1]</sup> Amendments noted where applicable.]

## Article I. Peddlers and Street Vendors

### § 77-1. Definitions.

For the purposes of this chapter, the following terms shall have the meanings set forth below:

#### **PEDDLER or STREET VENDOR**

Any person, whether principal or agent, who on any public street or sidewalk or in any public place sells or barter or offers to sell or barter; or carries or exhibits for sale or barter any goods, wares or merchandise, either on foot or from a vehicle, basket, stand, container or similar equipment or device. For the purposes of this chapter, the words "peddler" and "street vendor" shall be interchangeable.

#### **PUBLIC PLACE**

Any street, sidewalk, alley or other public way, any public park, square, space or grounds, any publicly owned or leased land or buildings.

#### **PUBLIC SIDEWALK**

That part of the public highway set aside for pedestrian traffic.

#### **PUBLIC STREET**

That part of the public highway set aside for vehicular traffic.

#### **PUSHCART**

Any wheeled vehicle or device, other than a motor vehicle, used by a street vendor in a public place, which may be moved with or without a motor and which does not require registration by the Department of Motor Vehicles.

#### **STAND**

Any movable, portable or collapsible structure, framework, table, stand, pushcart, container, basket or other equipment or device, other than a vehicle, used by a street vendor in a public place for the purpose of displaying, keeping or storing any goods or merchandise or any article used in the business of vending.

**VEHICLE**

Any motor vehicle as defined in the Motor Vehicles Law.

**VEND**

To peddle, hawk, sell, barter or lease; to offer to sell, barter or lease; or to display for sale, barter or lease any goods, wares, merchandise or services in a public street, sidewalk or place.

## § 77-2. License requirements.

- A. No street vendor, as herein defined, except those exempt under the Connecticut General Statutes or the provisions of this chapter, shall vend goods or merchandise in any public place within the City of Norwalk without first obtaining a license. The City Clerk of the City of Norwalk shall issue a license to any street vendor authorizing such street vendor to vend merchandise in the City of Norwalk, provided that such street vendor shall have fully complied with the provisions of this chapter and shall have made payment of the fee for said license.
- B. Each license issued pursuant to this chapter shall contain the full name of the street vendor, the license number, the year for which the license is valid and a nonremovable full-face photograph of the licensee.
- C. Each license issued pursuant to this chapter shall be visible upon the person of the licensee or otherwise conspicuously displayed at all times that said street vendor is engaged in the business of vending within the City of Norwalk.
- D. Each vehicle or stand used by a street vendor shall plainly display a sign or tag, issued by the City Clerk, bearing the license number issued to the street vendor and the year in which said license is valid.

## § 77-3. Exceptions.

The provisions of this chapter shall not apply to itinerant vendors as defined in Connecticut General Statutes, Section 21-27 (Revision of 1958) nor to sales by farmers and gardeners of the produce of their farms and gardens nor to the sale, distribution and delivery of milk, teas, coffee, spices, groceries, meats and bakery goods or to sales on approval or conditional sales of merchandise or to any organization or vendor which is an authorized participant in a special event approved by the city and for which a special event permit has been issued.

## § 77-4. License application.

- A. Applicants for a license under this chapter must file with the City Clerk a sworn application in writing on a form to be furnished by the City Clerk, which shall give the following information:
  - (1) The full name, home address, local address, if applicable, home and business telephone number and valid motor vehicle operator's license number or other approved form of identification of the applicant.
  - (2) The location of the applicant's principal office or place of business, if applicable.
  - (3) A description of the applicant setting forth the applicant's date of birth and social security number.
  - (4) The nature of the goods, wares or merchandise to be vended.

- (5) The make, year, type and registration number of any vehicle to be used for the vending of merchandise.
  - (6) A statement as to whether the applicant has ever been convicted of any criminal or motor vehicle offense.
- B. In addition, the applicant shall submit a signature, two copies of a recent photograph and conclusive proof of possession of a State of Connecticut sales and use of tax permit.

## § 77-5. Insurance required.

- A. Before any license as provided by this chapter shall be issued, the applicant shall file with the City Clerk a certificate of insurance naming the City of Norwalk as an additional named insured. Said certificate of insurance shall be in a minimum amount of \$1,000,000 providing coverage against any and all damage and injury to property or person by reason of, or related to, the licensee's use of public streets, sidewalks or placed to vend merchandise. Said insurance shall be maintained throughout the duration of the license period and failure to do so shall be a violation of this Code. All certificates of insurance issued, pursuant to this chapter shall contain a clause that 10 days' prior written notice of cancellation or change shall be given to the City Clerk of the City of Norwalk.
- B. An applicant shall also submit an executed agreement to indemnify and hold harmless the City of Norwalk and its officers, employees, agents and assigns from any and all claims, actions, injuries and damages of every kind and description which may accrue to or be suffered by any person by reason of or related to the vending of merchandise by said applicant or the granting of a license to do so.
- C. Failure to comply with the requirements of this section shall be cause for denial or revocation of the license.

## § 77-6. Issuance of license; fees.

- A. The fee for the issuance of a street vendors license shall be set at \$200. Modifications of the fee hereafter shall be made as set forth in the following subsection:
- (1) The Health, Welfare and Public Safety Committee shall, with the concurrence of the Common Council, make and alter fees for the street vendors license. The Committee shall establish the proposed fee and shall hold a public hearing thereon no less than seven and nor more than 14 days from the date of notice of the time and place of such hearing, published in the form of a legal advertisement appearing in a newspaper having a substantial circulation in the city. Within 90 days of receipt by the City Clerk of notice of the action taken by the Committee subsequent to the public hearing, the Common Council shall act upon the fee schedule. If the Council takes no action within 90 days, the rates and fees shall be deemed approved, and the City Clerk shall issue a notice so stating, which notice shall be maintained with the records of the Common Council. If the Council votes to disapprove the fee, it may itself establish any such fee or may ask the Committee to submit a revised fee to the Common Council.
- B. Refusal to issue.
- (1) Upon completion of a license application and payment of the license fee, the City Clerk shall issue a street vendor's license to the applicant. However, the City Clerk may refuse to issue such license or shall revoke said license forthwith by written notice for any of the following reasons:

- (a) If the applicant has given false or misleading information on the application.
  - (b) If the applicant fails to provide any information as required by this chapter.
  - (c) If the applicant has been convicted of any misdemeanor involving fraud within the last five years.
  - (d) If the applicant has been convicted of a felony crime involving fraud, unless five years has passed since the expiration of the applicant's felony sentence or parole.
- (2) Such issuance or refusal shall not be delayed longer than the requirements of a reasonable investigation may dictate.

## § 77-7. Duration of license.

Each license issued in accordance with this chapter shall be valid for the calendar year in which it is issued and shall expire on the 31st day of December of that year. Licenses shall not be transferable. No license shall be issued for any fractional period of a year nor shall any pro rata payment be permitted.

## § 77-8. Records to be kept by Clerk.

It shall be the duty of the City Clerk to keep a record of all licenses granted under the provisions of this chapter in a file provided for the purpose. Such record shall contain the number and date of each license, the information required under § 77-4 hereof, the amount of license fee paid and the date of any prior license revocations, as provided in this chapter. The City Clerk shall keep a detailed account of all his receipts for such licenses and make a return thereof monthly to the City Treasurer. The records kept under this section shall be open to public inspection.

## § 77-9. Areas of conduct restricted.

- A. No street vendor shall vend within 10 feet of any driveway, bus stop or crosswalk nor within 20 feet of any intersection nor within any metered parking space.
- B. No vehicle or stand or other item related to the operation of a vending business shall touch, lean against or be affixed to any building or structure, including but not limited to lampposts, parking meters, mailboxes, traffic signal stanchions, fire hydrants, tree boxes, benches, bus shelters, refuse baskets or traffic barriers.
- C. All goods, wares or merchandise vended by a street vendor shall be contained upon or within the vehicle or stand used by the street vendor or contained upon the person of said vendor. In no case shall any goods, wares or merchandise be placed directly upon a street, sidewalk or public place.
- D. No stand used for the purpose of vending shall be larger than five feet by three feet nor shall any stand be of such height that it obstructs the vision of pedestrian or motor vehicle traffic. All stands shall be of a portable nature.
- E. No vehicle or stand shall be so located or placed as to obstruct pedestrian or motor vehicle traffic or be detrimental or injurious to public safety or interfere with the use of any street, sidewalk or public place by the public at large.
- F. No stand used for vending shall be located upon a public street or highway. Any vehicle used for vending upon a street shall obey all traffic and parking laws, rules and regulations. In no case shall a

vehicle used for vending be placed so as to restrict the continued maintenance of a clear passageway for vehicular traffic.

## § 77-10. Vending in parks restricted.

No license issued pursuant to the provisions of this chapter shall be construed so as to permit the vending in any of the public parks of the city without approval pursuant to § ~~74-12.1~~ of this Code.

## § 77-11. Violations and penalties.

Each act of vending goods or merchandise in violation of any of the provisions of this chapter shall be deemed a separate offense and shall be subject to a fine not exceeding \$100.

## § 77-12. Revocation of license.

In addition to any other penalty provided by the Code of Ordinances or the Connecticut General Statutes, a violation of this chapter or of the terms of any license issued hereunder shall be grounds for the revocation of an issued license by written order of the City Clerk, without the return of the license fee.

## § 77-13. Applicability of other licensing requirements.

The provisions of this chapter shall not be construed to exempt any person from securing any other license or paying any other license tax which may be authorized and imposed by the Connecticut General Statutes or by any provisions of the Code of Ordinances of the City of Norwalk.

## § 77-14. (Reserved).

# Article II. Solicitors

## § 77-15. Definitions.

As used in this Article, the following terms shall have the meanings indicated:

### **SOLICIT**

The conditional sales of merchandise or the taking of orders for merchandise for further delivery when full payment is not required at the time of solicitation, or any sales made on approval.

### **SOLICITOR**

Any person who goes from place to place, house to house or dwelling unit to dwelling unit within a multidwelling building or who stands in any street, sidewalk or public place taking or offering to take orders for goods, wares or merchandise for future delivery or for services to be performed in the future.

## § 77-16. License required.

- A. No solicitor, as herein defined, over 16 years of age, except those exempt under the Connecticut General statutes or this chapter, shall solicit orders of purchase for any goods, wares or merchandise, including magazines and other printed matter, without first obtaining a license. Such license shall be issued by the City Clerk, provided that such solicitor shall have fully complied with the provisions of this chapter and otherwise met its requirements and shall have made payment of the fee for said license.
- B. Each license so issued shall contain the full name and address of the solicitor, the license number, the year for which the license is valid and a nonremovable full-face photograph of the licensee.
- C. Each license so issued shall be prominently displayed upon the person of the solicitor at all times that said solicitor is engaged in the business of soliciting orders within the City of Norwalk.

## § 77-17. Exemptions.

The provisions of this Article shall not apply to:

- A. The sales by farmers and gardeners of the produce from their farms and gardens.
- B. The sale, distribution and delivery of food and beverages.
- C. The sale of newspapers.
- D. The sale of insurance.
- E. Sales made to retail or wholesale stores or to professional or industrial establishments.
- F. Sales by an individual or organization which is an authorized participant in a special permit event approved by the city and for which a special event permit has been issued.

## § 77-18. License application.

- A. Each solicitor who is subject to the provisions of this chapter, shall make application to the City Clerk for a license. All such applications shall be on a form provided by the City Clerk and shall include but not be limited to the following information:
  - (1) The full name, home address, local address, if applicable, home and business telephone number and valid motor vehicle operator's license number or other approved form of identification of the applicant.
  - (2) A physical description of the applicant, setting forth the applicant's date of birth and social security number.
  - (3) The location of the applicant's principal office or place of business, if applicable, and the name and address of the person or organization for whom or through whom orders are to be solicited or cleared.
  - (4) The make, year, type and registration of any motor vehicle to be used for the soliciting of orders for the purchase of merchandise or services, if any.
  - (5) The nature of the goods, wares or merchandise for which orders are to be solicited and the period of time during which the applicant intends to solicit orders.

- (6) A statement as to whether the applicant has ever had a solicitor's license revoked or been convicted of a felony of any type or of a misdemeanor.
- B. In addition, the applicant shall submit a signature, two copies of a recent photograph and conclusive proof of possession of a State of Connecticut sales and use tax permit.

## § 77-19. Insurance required.

- A. Before any license, as provided by this Article, shall be issued, such applicant shall file with the City Clerk a certificate of insurance naming the City of Norwalk as the additional insured party. Said certificate of insurance shall be in a minimum amount of \$1,000,000 providing coverage against any and all damage and injury to property or person by reason of or related to the licensee's use of public streets, sidewalks or places to solicit orders for the purchase of merchandise or services. Said insurance shall be maintained throughout the duration of the license period, and failure to do so shall be a violation of this chapter. All certificates of insurance issued pursuant to this chapter shall contain a clause that 10 days' prior to written notice of cancellation or change shall be given to the City Clerk of the City of Norwalk.
- B. An applicant shall also submit an executed agreement to indemnify and hold harmless the City of Norwalk and its employees, officials and/or agents from any and all claims, actions, injuries or damages of every kind and description which may accrue to or be suffered by any person by reason of or related to the soliciting of orders for the purchase of merchandise or services by said applicant or the granting of a license to do so.
- C. Failure to comply with the requirements of this section shall be cause for the denial or revocation of the license.

## § 77-20. Issuance of license; fee.

- A. The fee for the insurance of a solicitor's license shall be \$100. Modification of the fee hereafter shall be made as set forth in the following subsection:
  - (1) The Health, Welfare and Public Safety Committee shall, with the concurrence of the Common Council, make and alter fees for the solicitors license. The Committee shall establish the proposed fee and shall hold a public hearing thereon no less than seven and no more than 14 days from the date of notice of the time and place of such hearing, published in the form of a legal advertisement appearing in a newspaper having a substantial circulation in the city. Within 90 days of receipt by the City Clerk of notice of the action taken by the Committee subsequent to the public hearing, the Common Council shall act upon the fee schedule. If the Council takes no action within 90 days, the rates and fees shall be deemed approved, and the City Clerk shall issue a notice so stating, which notice shall be maintained with the records of the Common Council. If the Council votes to disapproved the fee, it may itself establish any such fee or may ask the Committee to submit a revised fee to the Common Council.
- B. No fee shall be required from any resident of this state who is a veteran as defined by the Connecticut General Statutes, Section 27-103 (Revision of 1958), as amended, provided that suitable evidence is presented of these facts by the applicant. No fees shall be required from any religious, charitable, fraternal or nonprofit organizations nor from representatives of such organizations; provided, however, that the City Clerk and the Chief of Police must both agree that any organization and its representatives fall within this exemption, and such organizations and their representatives shall file with such officials such information as they shall require to make such determination.

C. Refusal to issue.

- (1) Upon completion of a license application and payment of the license fee, the City Clerk shall issue a solicitor's license to the applicant. However, the City Clerk may refuse to issue such license or shall revoke said license forthwith by written notice for any of the following reasons:
  - (a) If the applicant has given false or misleading information on the application.
  - (b) If the applicant fails to provide any information as required by this chapter.
  - (c) If the applicant has been convicted of any misdemeanor involving fraud within the last five years.
  - (d) If the applicant has been convicted of a felony crime involving fraud, unless five years has passed since the expiration of the applicant's felony sentence or parole.
- (2) Such issuance or refusal shall not be delayed longer than the requirements of a reasonable investigation may dictate.

## § 77-21. Duration of license.

Each license issued in accordance with this chapter shall be valid for the calendar year in which it is issued and shall expire on the 31st day of December of that year. Licenses shall not be transferable. No license shall be issued for any fractional period of a year nor shall any pro rata payment be permitted.

## § 77-22. Restricted activities.

- A. A solicitor's license issued under the provisions of this chapter shall not constitute a license to enter any area where restrictions on public access are in effect.
- B. No solicitor shall engage in the soliciting of orders except between the hours of 8:00 a.m. to 8:00 p.m.

## § 77-23. Conduct; receipts required.

Any person soliciting an order of purchase for future delivery of goods, wares and merchandise shall conduct himself or herself at all times in an orderly and lawful manner and shall give a written receipt, signed by the solicitor, of all orders so taken. Such receipt shall set forth a brief description of the goods, wares and merchandise ordered, the total purchase price thereof, the amount of down payment received by the solicitor from the purchaser and the approximate date of delivery.

## § 77-24. Violations and penalties.

Each order solicited in violation of the provisions of this chapter and each false statement or misrepresentation of fact for the purpose of obtaining a solicitor's license shall be deemed a separate offense and shall be subject to a fine not exceeding \$100.

## § 77-25. Suspension or revocation of license.

In addition to any other penalty provided by the Code of the City of Norwalk or the Connecticut General Statutes, a violation of this chapter or of the terms of any license issued hereunder shall be grounds for the revocation of an issued license by written order of the City Clerk, without the return of the license fee.

## **§ 77-26. Applicability of other licensing requirements.**

The provisions of this chapter shall not be construed to exempt any person from securing any other license or paying any other license tax which may be authorized and imposed by the Connecticut General Statutes or by any provisions of the Code of the City of Norwalk.
