Public Participation Instructions Below

- I. **14 Elm Street** – Section 118-360(B) - **Creation of an apartment (or apartments) within a legally, non-conforming 3-Family Residence (non-conforming for lot size), on a property located within a 'D-Residential' zone** - Principal uses and structures within a D Residential Zone; premises shall be used and buildings shall be erected which are used, designed or intended to be used for one (1) or more of the following uses and no other as described in this section.

- II. **200 West Rocks Road** – Section 118-1220(J) – **Creation of parking within the front setback** - All off-street parking and loading facilities, including all parking aisles and backup spaces needed for vehicle maneuvers into and out of parking spaces, shall be located to the rear of the required front setback line as now or hereafter established. The area between the street line and the front setback line, and on a corner lot, the side setback line along a street, except for the required access driveway and pedestrian sidewalk leading from the street to the off-street parking and loading area, shall be landscaped with lawns or other appropriate planting. ****Hearing Officer Continued matter at the 11/1/2023 Hearing****
- III. **4 France Street** – (Section 118-1420 (E), (F), & (G)) – **Addition of/Placement of a detached structure without applying for, obtaining a Zoning Approval & obtaining a Certificate of Zoning Compliance (conversion of garage to living space)** ****Hearing Officer Continued Matter at 1/26/22 & 4/20/2022 & 6/28/22 & 8/30/2022 & 9/21/2022 & 11/30/2022 & 2/1/2023 & 3/15/2023 & 4/12/2023 & 6/14/2023 & 7/26/2023 & 9/20/2023 & 11/1/2023 & 12/13/2023 & 1/10/2024 Hearing, also, Assessed a \$12,000 fine & placed a \$12,000 Contingent fine at 3/15/2023 Hearing****
- IV. **7 Knob Hill Road** - (Section 118-330B) - **Creation of a multi-family use on a property located within an 'A-Residential' zone** - In an A Residence Zone, premises shall be used and buildings shall be erected which are used, designed or intended to be used for one (1) of the following uses and no others. See Building Zone Regulations for the City of Norwalk for list of uses. ****Continued by Hearing Officer at 5/08/2019 & 06/12/2019 8/1/2019, & 10/10/2019 & 11/14/2019 & 12/18/2019 & 5/18/2022 & 8/2/2022 & 9/21/2022 & 2/1/2023 & 5/17/2023 & 6/14/2023& 9/20/2023 & 11/1/2023 & 12/13/2023 Hearings AND placed a \$10,000 contingency fine at the 8/2/2022 Hearing****
- V. **13 Harriet Street** – (Section 118-350(B)) - **Conversion of a 2-Family Residence to a 4-Family Residence, on a property within a 'C-Residential' zone** - Principal uses and structures. In an C Residence Zone, premises shall be used and buildings shall be erected which are used, designed or intended to be used for one (1) of the following uses and no others. See Building Zone Regulations for the City of Norwalk for list of uses. ****Hearing Officer Continued Matter at the 1/4/2023 & 10/11/2023 & 12/13/2023 Hearing; also, placed a \$30,000 Contingent Fine at the 10/11/2023 Hearing****
- VI. **10 Harris Street** - Section 118-1420 (E), (F), & (G)) – **Additions/Alterations to structure without applying for, obtaining a Zoning Approval & obtaining a Certificate of Zoning Compliance (conversion of garage to living space)** – AND (Section 118-1220(J)) – **Creation of parking within the front setback** - All off-street parking and loading facilities, including all parking aisles and backup spaces needed for vehicle maneuvers into and out of parking spaces, shall be located to the rear of the required front setback line as now or hereafter established. The area between the street line and the front setback line, and on a corner lot, the side setback line along a street, except for the required access driveway and pedestrian sidewalk leading from the street to the off-street parking and loading area, shall be landscaped with lawns or other appropriate planting. ****Hearing Officer Continued Matter at 1/26/2022 & 4/20/2022 & 5/18/2022 & 9/21/2022 11/30/2023 & 2/22/2023 & 10/11/2023 Hearing & Placed a \$1,000 contingent fine at 11/30/2022 Hearing****
- VII. **7 Norvel Road** – Section 11-340(B) - **Creation of a 2-Family Residence/rooming house, on a property located within a 'B-Residential' zone** - Principal uses and structures. In a B Residence Zone, premises shall be used and buildings shall be erected which are used, designed or intended to be used for one (1) of the following uses and no others. See City of Norwalk Building Zone Regulations for list of allowed uses with 'B-Residential' zone.

- VIII. **61 Ohio Avenue Extension** – (Sections 118-1420 (E), (F), & (G)) – **Construction of a shed, which impedes required parking for property, without applying for a Zoning Approval, obtaining a Zoning Approval, & obtaining a Certificate of Zoning Compliance.** **Hearing Officer Continued matter at the 8/23/2023 Hearing**
