I. CALL TO ORDER

Mr. Klocke called the meeting to order at 6:02 p.m. It should be noted that this meeting was held on Zoom.com with all participants calling in, separately.

B. #S26-662 – 26 Cannon Street – City of Norwalk DPW – Replacement of storm drainage system in and adjacent to wetlands and a watercourse

Ms. Cherichetti noted that this had been received at the previous meeting. The applicant has revised their plans and provided additional information including a drainage report. She said she had sent the Agency members a draft resolution earlier in the day for review.

Paul Sotnik, Senior Civil Engineer for the Department of Public Works (DPW), reviewed the updated plans and replanting plan for the property.

Jennifer Martinez Torres, a consultant with Woodard & Curran, continued the presentation with a discussion of two trees that would be included in the demo plan. The other plan that had been updated was the restoration plan which showed the locations of the plants, including the species, quantities and the sizes. An updated drainage report had been provided to them.

Ms. Cherichetti said that the plants were all native to Connecticut and would be appropriate for the location. There was a discussion of the material type of the pipe which Ms. Martinez Torres said was reinforced concrete.
